PARTICIPATION CONDITIONS / GAME PROCEEDINGS

The game begins on 1 May, 2020. The game is accessible on Internet via the URL <u>https://www.nouvelle-aquitaine-tourisme.com/en/campaign/tourism-solidarity-sayhello</u>

The game is open to all natural persons residing in France or abroad.

In order to participate, players must :

Complete and validate the form with their : last name, first name, e-mail address, and agree to the game rules to validate their registration. Signing up for the Nouvelle-Aquitaine Tourism Board's newsletter is not compulsory for participating in the game.

- 2. Click on the « Validate » button to begin to **#SAYHELLO**
- 3. Players must record a 5 (or less) second video of themselves saying « Hello » in the language of their choice, then upload it before 15 June on the available platform. Players can stage their performances and use accessories that are typical of Nouvelle-Aquitaine's destinations!
- 4. Once players have uploaded their video on the platform, they will be asked to indicate their nationality and specify which Nouvelle-Aquitaine destination they wish to send their « Hello » to. Players can also add a few words ;
- 5. Players will then be asked to validate their participation by clicking on the « validate » button
- Starting on June 16, a vote will be available on the contest page to select the contest's 30 best videos which will become part of **our official « To continue to say** Hello » campaign.

One vote per person and per day will be taken into account, for the participant of your choice.

7. Players can also share their participation on Facebook, by clicking on « Share on Facebook ».

WINNER DESIGNATION

From 16 June to 15 July 2020, all of the uploaded videos will be submitted to the public for a vote. The 30 videos with the most votes will become part of our official « To continue to say hello » campaign and will receive a prize according to their ranking.

There can only be one winner per family, same last name, same e-mail address.

PRIZES

The game comprises several prizes which will be attributed to the 30 winners selected by the public. The list of prizes is as follows :

1st prize : a 6 days' / 5 nights' stay for 2 adults and 2 children in Nouvelle-Aquitaine for an approximate value of 900 €

2nd and 3rd prizes : a meal for 2 in a gourmet restaurant in Nouvelle-Aquitaine, for an approximate value of 200 €
