

## **“YOUR DREAM GETAWAY WITH CLUB MED” SWEEPSTAKES**

### *OFFICIAL RULES APPLICABLE TO ENTERING THE SWEEPSTAKES*

*NO PURCHASE OR MONETARY CONSIDERATION NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW. ENTRY IS FREE.*

*THE SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH, FACEBOOK.*

#### **1. SPONSOR**

The “Your Dream Getaway with Club Med” sweepstakes (“**Sweepstakes**”) is administered and sponsored by Club Med Sales, Inc, 6505 Blue Lagoon Drive, 225, Miami, Florida 33126 United States of America (“**Club Med**”).

#### **2. AGREEMENT TO OFFICIAL RULES**

By entering the Sweepstakes, Entrants (as defined below) agree to be bound by these Official Rules (“**Official Rules**”) and Club Med’s decisions, which are final and binding in all matters relating to the Sweepstakes. Winning the prize is contingent upon fulfilling all requirements set forth herein.

#### **3. SWEEPSTAKES ENTRY**

The Sweepstake begins on July 18, 2022 at 12:00 AM Eastern Standard Time (“EST”) and ends on August 07, 2022 at 11:59: PM EST (“**Sweepstakes Period**”). For purposes of these Official Rules all times and days are EST. Club Med’s servers are the official time-keeping device for the Sweepstakes.

#### **4. ODDS OF WINNING**

Odds of winning a prize depend on the number of eligible entries and additional participations received during the Sweepstakes Period. Limit of one (1) entry per person during the Sweepstakes Period. One (1) entry equals to one (1) participation.

Any attempt or suspected attempt to submit more than one entry and/or to obtain more additional participations than permitted by using multiple e-mail addresses or a pen name, or any use of robotic, automatic, programmed or any entry methods not authorized by these Official Rules shall be deemed as tampering and will void all of your entries.

By entering these Sweepstakes, entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

#### **5. WHO CAN ENTER**

The Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least 18 years of age or have reached the age of majority in their jurisdiction of residence at the time they enter the Sweepstakes.

2. Click the checkbox confirming eligibility requirements and that you have read and agree to these Official Rules and the Sponsor's Privacy Policy (<http://www.clubmed.us/privacy-policy>) IF THIS BOX IS NOT CHECKED, YOU WILL NOT BE ABLE TO COMPLETE THE ENTRY FOR THE SWEEPSTAKES, then click the designated button to submit your entry. All entries must be received by August 07, 2022 at 11:59: PM EST. Internet access and usage charges may apply from Entrant's on-line service.
3. Entrant may choose to click the checkbox consenting to receive promotional communications from the Sponsor. Entrants may opt-out of future promotional communications by following the "Unsubscribe" directions for e-mails. YOU ACKNOWLEDGE THAT YOU ARE NOT REQUIRED TO CONSENT TO RECEIVE PROMOTIONAL MATERIALS AS A CONDITION OF ENTERING THIS SWEEPSTAKES.
4. Entrant must participate to the swiping game in order to be entered to the sweepstake.

## 7. PRIZE

Among all valid Registration Forms and Mail-in Entries and subject to the conditions below, **ONE** (1) Grand Prize will be awarded which shall consist of:

**GRAND PRIZE: ONE** (1) all-inclusive seven (7)-night vacation package (the "**Vacation Package**") for two (2) Adults ("**Travelers**") staying in the same room at one of the following resorts: Club Med Punta Cana (Dominican Republic), Club Med Cancun (Mexico), Club Med Ixtapa (Mexico), Club Med Quebec Charlevoix (Canada), Club Med Miches Playa Esmeralda (Dominican Republic). The Vacation Package includes the following services and amenities:

- o Roundtrip transfers from the closest airport to the Resort;
- o Seven (7) hotel night accommodation for the Travelers in one (1) superior Club room (double occupancy)

- o Meals, snacks, drinks and activities at the Resort as described in the Trident brochure applicable as of the travel date.

The foregoing components collectively constitute the “**Grand Prize**”.

The total retail value of the Grand Prize is approximately Three Thousand Two Hundred United States Dollars (USD \$3,200).

## **8. CONDITIONS APPLICABLE TO GRAND PRIZE**

The following conditions apply to the Grand Prize:

- (1) Travel must take place before July 18, 2023 and be booked at least 2 months in advance.
- (2) Blackout dates apply.
- (3) Unless explicitly included in the Prize description above, all costs, charges or expenses, including without limitation all other traveling expenses, money allocation, all taxes (including income, airport, hospitality or other taxes if applicable), insurance, fuel surcharges, travel related fees and items of a personal nature, passports and other travel documents, meals and beverages, internet access charges, bar and wine charges, souvenirs, room service, gratuities and local and long distance telephone calls are the sole responsibility of the Winner (as defined below) and his/her guests.   - o À la Carte Sports such as kitesurfing;
  - o Babysitting and Pyjamas Club Med;
  - o Teen Spa;

  - o Complimentary or optional insurance coverage;
  - o Any additional charge linked to the trip;
  - o Any extra in-flight charges (i.e: food, drink, entertainment);
  - o Food, drinks, activities, excursions, tours and personal expenses, tips, and any other activity not included in the Trident brochure applicable at the booking date;
- (4) Travel arrangements shall be made by Club Med. Winner and his/her guests must travel together. Winner must give Club Med the name appearing on his/her

passport or on his/her identification paper used to travel, as well as the name and contact information of his/her guest. Winner and guest are solely responsible for obtaining the documents necessary for their respective international travel (i.e. passport/visa). Once the arrangements are completed, no modifications will be accepted;

- (5) No compensation will be awarded to the Winner or his/her guest if the actual value of the traveling expenses is less than the approximate retail value detailed hereinabove;
- (6) If the Prize or any part of the Prize is not used, no compensation will be awarded to the Winner and/or his/her guests;
- (7) The Prize may be accepted by the Winner in whole or in part. In the event that the Prize is accepted in part by the Winner, Club Med shall have no other obligation than to provide to Winner such accepted part of the Prize. Winner shall not be entitled to claim any part of the Prize that he/she has refused and Club Med shall be released of any obligations pertaining to such refused part of the Prize;
- (8) All accepted parts of the Prize must be used by the Winner during the same trip;
- (9) All federal, state or local taxes are the sole responsibility of Winner and/or his/her guest. Winner must cooperate with Club Med in order to complete all applicable federal, state or local documentation pertaining to taxation;
- (10) No prize substitution or cash redemption allowed by the Winner. The Prize is not transferable. Club Med reserves the right to substitute a prize of comparable or greater value if any portion of the featured Prize becomes unavailable.

## **9. RANDOM DRAW, WINNER NOTIFICATION AND SELECTION OF ALTERNATE WINNER**

The winner of the Sweepstakes will be selected from among all eligible entries received before the end of the Sweepstakes Period in a random drawing (the “**Grand Prize Winner**”). The random drawing will be conducted by Adictiz, 2 Rue Fourier, 59000 Lille . France. The drawing will take place on or about August 8th, 2022.

The selected Entrant will be notified by telephone and/or by e-mail within five (5) business days following the draw.

In the event the selected Entrant:

- 1) is unreachable by telephone or e-mail within five (5) business days following the draw; or
- 2) does not or cannot reply within five (5) business days of being notified; or
- 3) fails to comply with all the conditions in Section 10 below;

such selected Entrant will forfeit the Prize.

The forfeited Prize may be awarded to an alternate Winner in a random draw under the same conditions as aforementioned from all remaining eligible entries received for the Sweepstakes (the “**Alternate Winner**”). The same process will continue among the remaining Entrants until an Alternate Winner has been determined and qualifies.

## **10. WINNER QUALIFICATION**

In order to be declared Winner, the Entrant selected pursuant to Section 9 above must meet the following conditions:

### **13. GENERAL**

#### **16. DISPUTES, CHOICE OF LAW, CHOICE OF LANGUAGE AND SEVERABILITY**

As a condition of participation in this Sweepstakes, each Entrant agrees that any and all disputes that cannot be resolved between the parties, and all causes of action arising out of or in connection with the Sweepstakes shall be resolved individually, without resort to any form of class action, exclusively before a court located in the county of Miami-Dade, in the State of Florida, having competent jurisdiction, which court shall apply the laws of the state of Florida, without regard to the conflicts of laws principles thereof. The Entrant and Club Med hereby waive any and all right to trial by jury. If any provision of the Official Rules is declared or found by a court of competent jurisdiction to be illegal, unenforceable or void, then such provision will be null and void but each other provision hereof not so affected will be enforced to the fullest extent permitted by applicable law. Any and all claims, judgments and awards shall be limited to out of pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorney’s fees and under no circumstances will Entrant be permitted to obtain awards

for, and Entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages.

**17. LANGUAGE**

In the event of a conflict between the English version of the Official Rules and any other versions in any other languages, the English version shall prevail.
